- That adequate sports materials shall be purchased and made available to the students immediately.
- That the school shall strictly abide by the provisions of Delhi School Education Act & Rules, 1973.
- That the enrolment in each section shall not exceed the number of students calculated @ 12 sq.ft. per student for the available floor area of the classroom and the school shall provide adequate and sufficient accommodation as per the norms of the Directorate of Education, Delhi in each class.
